

Application Procedures

To apply for the Platinum Printing Workshop, please complete and sign the application form and return it with a deposit of \$150.00 which includes a non-refundable acceptance fee. If you do not become enrolled in this workshop, this fee is refunded.

Because of the modular nature of this workshop, wherein each session builds upon the previous one, if your schedule requires that you are unable to begin on the appointed start date, or must depart prior to the end of the workshop, please make arrangements to participate at a later workshop.

Acceptance Criteria

Applicants are evaluated for enrollment based upon the information provided, with special attention being given to the **Background Information**. Upon successfully becoming enrolled in this workshop, you will be sent a letter providing more detailed information on how to prepare for this workshop.

Applicants who are on the waiting list for this fall workshop will be given preference for standby after September 15th, or the Winter Workshop, but enrollment is not automatic or guaranteed. Place in the waiting list is determined by the date and time of receipt of the completed application form.

Payments

Please make all payments in Canadian Dollars, and make cheques or money orders payable to "PhotoVision Co., Ltd.". Credit Cards are not accepted for workshop deposits. Application forms submitted without a deposit are not processed.

The balance of the fee for the fall workshop is due no later than September 15, 2003. If payment in full is not received by that date, the deposit and place in the workshop will be forfeited, and your place will be filled from the waiting list.

Fees

Workshop fees cover tuition only. It is the responsibility of the applicant to make application directly to the Banff Centre For The Arts by downloading their application form which also provides for meal plan to suit the individual. Ten bachelor suites on campus have been reserved for this workshop during this period. The participant pays directly to the Banff Centre For The Arts for accommodation and meal plan.

Withdrawal, Workshop Cancellation And Refund Policy

Successful applicants may withdraw from the workshop any time prior to September 15th, 2003. The deposit or tuition, whichever applies, will be completely refunded less the \$100 Acceptance Fee. No refunds of any kind will be made for withdrawal after September 15th, 2003, during the workshop, or for no-shows.

Notification of cancellation due to insufficient enrollment will be made prior to September 15th, 2003. Because of this, you are encouraged to purchase refundable airline tickets, and consider purchasing trip cancellation insurance. Neither the Banff Centre For the Arts, PhotoVision Co., Ltd. nor Dr. Allan W. King will be responsible for any losses on airline tickets, or any other losses, related to cancellation of the Platinum Printing Workshop.
